As Australia and New Zealand emerge from the coronavirus crisis, construction has continued to be flagged as a critical sector for economic recovery. Few sectors make as significant a contribution to GDP and employment as construction and all the connected manufacturing, supply and services industries. Australia and New Zealand's leaders are backing the sector to play a pivotal role through substantial government investment and fast-tracked approvals. Take a look into some of the construction stimulus measures and just a handful of the many projects benefitting.

Queensland

Renewing Our Schools Program

We have 3 builders named as having tendered on the Sarina State High School Performing Arts & Sports Hall, and expect the contract to be announced within the next 3 - 4 weeks.

NEW ZEALAND

- Prior to the impact of the coronavirus outbreak, the government had already announced economic stimulus measures, including the NZD \$12 billion infrastructure stimulus programme.
- In April the government established the Infrastructure Industry Reference Group, tasked with looking for projects with a value of more than NZD \$10 million that could enter construction as soon the industry can restart after the COVID-19 stand-down. A list of 802 submissions was sent to Cabinet Ministers for consideration with the list expected to be cut further before the successful projects are announced.



AUSTRALIA




- Prime Minister Scott Morrison announced AUD \$1.5 billion in federal funding to prioritise 15 major road and infrastructure projects across Australia's states and territories.
- In addition, the Infrastructure Stimulus Package targeted at projects for local councils will provide AUD \$500 million for local roads and community infrastructure and an AUD \$1.3 billion fast-tracked grant program with funds to be available from 1 July.

VICTORIA

- Formation of the Building Victoria's Recovery Taskforce began by fast-tracking approval of four landmark projects in April. In May, the Taskforce approved more projects including 5 major projects with a value of over AUD \$800 million and continued to request submissions of projects with suitable state and regional priority.
- AUD \$2.7 billion boost to construction aimed at "shovel-ready" projects mainly in education infrastructure and public and community housing, some of which are already 'in the works' or previously announced.






NEW SOUTH WALES

- The Planning System Acceleration Program aims to cut red tape and expedite assessment processes.
- Fast-tracked assessments for projects where development approvals are capable of proceeding to construction within 6 months have been announced, with Tranche One in April comprising 24 projects and planning proposals, and Tranche Two in May comprising 16 projects and 8 planning proposals.
- AUD \$70 million earmarked for housing infrastructure (drainage, roads, parks etc.) to allow already-approved housing developments to get started.





QUEENSLAND

- The AUD \$200 million Works for Queensland COVID Recovery Package is to support local jobs and local governments with funding for building productive infrastructure.
- AUD \$235 million was invested in the Renewing Our Schools program, which will upgrade education infrastructure across the state.
- An agreement with the federal government was reached to bring forward construction and upgrade works proposed as part of the Roads of Strategic Importance (ROSI) initiative.
- In May, an AUD \$400 million Accelerated Works Program was announced with a substantial capital and maintenance roads program.

SOUTH Australia

The state's AUD \$1 billion economic stimulus package includes over \$130 million for new infrastructure projects, targeted regional road repairs and major highways.



WESTERN Australia

- A state-wide Construction Panel was established to expedite delivery of projects across WA, with:
 - New streamlined process for transport construction contracts worth up to AUD \$20 million
 - Support for small to mid-sized contractors during the COVID-19 crisis
 - More than AUD \$140 million of road and maritime projects including vital road safety
- Main Roads is also fast-tracking the tendering process for a number of large-scale road projects, worth AUD \$2.37 billion and estimated to create 13,000 jobs.
